



Quality indicators help schools, education authorities and inspectors to judge what is good and what needs to be improved in the work of the school. Following the inspection of each school, the Scottish Government gathers evaluations of three important quality indicators to keep track of how well all Scottish schools are doing.

The Care Inspectorate publishes quality grades to inform people and the Scottish Government about the quality of care services. Awarding grades at inspections is aimed at encouraging providers to identify and address areas for improvement. The Care Inspectorate also uses the grades to ensure our inspection activity is targeted and proportionate. At the last inspection that was conducted by the Care Inspectorate, there were no recommendations and one requirement which has not been met. Outstanding issues relating to making improvements to the nursery environment to ensure that it provides accommodation which is in a good state of repair and decoration are carried forward in this letter.

Requirements

 The service provider must make improvements to the nursery environment to ensure that it provides accommodation which is in a good state of repair and decoration. This is in order to comply with The Social Care and Social Work Improvement Scotland (Requirements for Care Services) Regulations 2011 (Scottish Statutory Instrument 2011/210) - regulation 10.(2)(b)(c)
 A regulation with regard to ensuring premises are of sound construction and kept in good order and repair.

Timescale: Within 12 weeks from receipt of this report.

• The provider must ensure that personal plans are put in place for each child. These should be devised in consultation with parents and carers, making sure each child's individual needs are met. These should be reviewed and updated at least every six months. This is in order to comply with The Social Care and Social Work Improvement Scotland (Requirements for Care Services) Regulations 2011 (Scottish Statutory Instrument 2011/210) - regulation 5 (1), (2) (a) and (b) (i) (iii) Personal Plans.

Timescale: 12 weeks from receipt of this report.

Recommendations

- The provider should ensure that children have opportunities to be more involved in serving their snack. National Care Standards for Early Education and Childcare up to the age of 16: Standard 5 – Quality of experience.
- Staff who had not done so should arrange to attend training on infection control, keeping them up to date with best practice guidance. National Care Standards for Early Education and Childcare up to the age of 16: Standard 2 – A safe environment.

A notification from the Care Inspectorate will be sent to the Provider to complete and action plan to address the Requirements and Recommendations made as a result of this inspection.
